



PLAYER WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I, the undersigned player, acknowledge, agree, and understand that:

1. Voluntarily and of my own free will, elect to participate in Indiana Grizzlies, Inc. Youth Football Program. Furthermore, I agree that I am in good health and proper physical condition to participate in tackle football.
2. I understand that there are certain risks and hazards involved in participating in football that may result in injury or death to me or other players including, but not limited to those hazards associated with, playing conditions, equipment, and other participants.
3. I understand that football is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of football is hazardous and risky, including, but not limited to, the acts of running, jumping, stretching, sliding and collisions with other players and stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play football and in consideration for permission to play:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, (c) while on or upon the premise of any and all fields arranged for by my team or league for practice or play, and (d) while attending any Indiana Grizzly event.
2. I hereby release, discharge, and agree not to sue Indiana Grizzlies, Inc. or their owners, officers, agents, servants, associations, coaches, or any other person or entity connected with Indiana Grizzlies, Inc. for any claim, damages, costs, or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND AGREE TO ABIDE BY THEM.

PARENT/GUARDIAN WAIVER, RELEASE OF LIABILITY, AND INDEMNIFICATION AGREEMENT

I, the undersigned parent/guardian of the above-named minor, acknowledge, agree, and understand that:

1. The above-named minor is in good health and proper physical condition to participate in tackle football.
2. There are certain risks and hazards involved in the above-named minor participating in football that may result in injury or death to the minor or other players, including but not limited to those hazards associated with, playing conditions, equipment, and other participants.

I hereby release, discharge, and agree not to sue Indiana Grizzlies, Inc., or their owners, officers, agents, servants, associations, coaches, or any other person or entity connected with Indiana Grizzlies, Inc. for any claim, damages, costs, or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by the above named minor from whatever cause, including but not limited to negligence, breach of contract, or wrongful conduct of the parties hereby released.
